## Good Hope City Council Minutes August 3, 2020

**Due to Covid -19 the City Council meeting was held on site and through conference call.**

### Prior to the meeting

Kelsey Malcom was sworn into Council Seat Post 2, replacing Jason Laughinghouse

- 1. Call to Order:** Mayor Guthrie called the meeting to order. Council Member Keith Prather led the invocation. Council Member Kelsey Malcom led the pledge.
- 2. Roll Call** was performed by City Clerk, Renette Yancey. Council Members Keith Prather, William Malcom and Kelsey Malcom were present at City Hall. Council Members David Mullis and Josh Jameson attended via conference call.
- 3. Approval of Agenda:** Council Member William Malcom made a motion to accept the August agenda. Councilman Kelsey Malcom seconded. All approved and the motion was passed.
- 4. Approval of previous meeting's minutes:** Councilman Josh Jameson made a motion to accept the July Council minutes. Councilman David Mullis seconded. All approved, Motion passed, and the minutes were recorded.
- 5. Public Forum:** There was no Public Forum
- 6. Committee Reports/Updates:**
  - A. CARES Act Funding.** Mayor Guthrie has consulted with several Mayors, David Mullis, and Keith Prather for their opinion on the CARES Act Funding. Our understanding is that the first amount of \$4711.00 needs to be spent in the month of September. The GMA will be holding webinars for more guidance. The list of what can be purchased include mask, hand sanitizer, gloves, and a cabinet to store supplies in. Anything that relates to COVID. The mayor has spoken with Carl Morrow and others for a list of suppliers. A CARES Act bank account will be opened for this project.
  - B. Emergency Generator.** The generator was serviced, and the cost was \$235.00. We can sign a 3-year contract for \$630.00 This will save the city money. Mayor will see if this can be paid with SPLOST money.
  - C. Gateway Signs.** The cost of the signs coming into the city is \$2400.00. Before the DOT will approve the project, they require more information. Mayor Jimmy Guthrie has been in touch with Todd Parker from Precision Planning INC. for assistance with the DOT and now we are waiting on approval.
  - D. Copier/Printer update.** We have narrowed our choice of printers to three. Xerox Versa Link cost \$605, Brother 8900 cost \$509 and the Xerox 6515 cost \$329. Mayor Guthrie has found the best price for each and has inquired about the machines with people that service the machines.
  - E. Good Hope General** is sold, and the transfer is being performed today. City Clerk Renette Yancey has completed the paperwork for the business license and Mayor Jimmy Guthrie will deliver the license.
- 7. Unfinished Business:** There is no unfinished business
- 8. New Business**

**A. CARES Act Resolution.** Mayor Guthrie presented the Good Hope Cares Act Resolution. Councilman Keith Prather made a motion to pass the resolution and Councilman William seconded. All approved and the resolution was passed Councilman David Mullis and City Clerk Renette Yancey were appointed to be secondary signers.

**B. Maintenance Contract for Emergency Generator.** Council Member Keith Prather made a motion to enter into a 3-year contract for service on the Generator maintenance agreement. Council Member William Malcom seconded. All approved. Motion passed.

**C. Gateway Signs.** Council Member William Malcom made a motion to accept the purchase of the Gateway signs. Council Member Kelsey Malcom seconded. All approved. Motion passed.

**D. New Copier Printer for City Hall.** Council member Kelsey Malcom made a motion to accept the purchase of the Xerox Versa Link for \$605. Council Member Josh Jameson seconded. All approved. Motion passed.

**9. Council Discussion Items:**

**A.** Mayor Guthrie thanked Kelsey Malcom for stepping in and being willing to serve the City of Good Hope as a member of the City Council.

**10. Adjourn:** Mayor Guthrie called for a motion to conclude the meeting. Council Member Keith Prather made the motion, Council Member William Malcom seconded. Motion passed and the meeting was adjourned.
