Good Hope City Council Meeting  
Date February 1, 2021

Judge Burke was unable to attend the meeting to swear in the Council Members.

1. **Call to order / Invocation / Pledge of Allegiance** Mayor Pro-Tem David Mullis called the meeting to order. Councilmember Keith Prather gave the invocation and Councilmember William Malcom led the Pledge of Allegiance.
2. **Roll call:** City Clerk Renette Yancey took roll. All were present.
3. **Approval of agenda:** Councilmember William Malcom made a motion to accept the agenda. Councilmember Keith Prather seconded, all approved and motion was passed.
4. **Approval of previous meeting's minutes:** Councilmember Keith Prather made a motion to accept the January minutes. Councilmember Kelsey Malcom seconded, all approved, motion was passed, and the minutes were recorded.
5. **Public Forum:** Jimmy Guthrie spoke to the Council and expressed his love for the city and his appreciation for the chance to have served the City on the Council and as Mayor. He said he had complete confidence the council going forward. He gave the Council a few words of advice which he said were passed to him when he became Mayor. His advice to the council to always remember to treat others as you would like to be treated.

The city had \$10,500.68 in SPLOST money that was to be used on sidewalks but had not been spent. Randy Garrett has been working to get the remaining amount for the city. The money will be used for the Preparation (PPI) of the sidewalks down Pleasant Valley Rd.

6. **Committee reports/updates:**
  - A. **2020 Mayors Report** – Mayor Pro-Tem David Mullis prepared the Mayors report and presented all members of the council with a copy.
  - B. **2020 Budget Report** – The city came in under budget this year.
  - C. **LMIG Update** – Mayor Pro-Tem David Mullis worked with Todd Parker and got the city's LMIG application submitted, only to learn the city was not in compliance with the audit filing requirements. After several e-mails between himself, City Clerk Renette Yancey, and Jackie from the state we were able to provide the information required and are now in compliance with our filing. This makes the city eligible for monies in the year 2021.
  - D. **SPLOST 2007**-Randy Garrett was able to get the unused SPLOST money for the city.
  - E. **Tree Committee**- Five trees have been planted around the playground. This will provide shade for the citizens of Good Hope as they enjoy the use of the playground and pavilion.
7. **Unfinished business:** The roof in City Hall has a leak. Bone Dry Roofing is the name of the company the City used the last time there was an issue. Mayor Pro-Tem David Mullis will contact them.
