Good Hope City Council Minutes May 3, 2021

Before the meeting Mayor Randy Garrett introduced the new clerk, Missy Daigle, to the Council Members, with the exception of David Mullis, Jr. who was out of town. The Mayor and Council also presented a plaque to Renette Yancey in recognition of her service as City Clerk.

1. **Call to order:** Mayor Randy Garrett called the meeting to order followed by the invocation. Councilman Keith Prather led the pledge.
2. **Roll Call:** Performed by City Clerk Missy Daigle, Council Members William Malcolm, Kelsey Malcolm, and Keith Prather were in attendance. Also, in attendance was the former City Clerk Renette Yancey.
3. **Approval of agenda:** There were no amendments to the agenda, a motion was made by Keith Prather to keep the agenda as it was and Kelsey Malcolm seconded the motion.
4. **Approval of previous meeting's minutes:** Councilmember William Malcolm made a motion to accept April Council minutes. Councilmember Keith Prather seconded, all approved, motion passed and minutes were recorded.
5. **Public Forum:** There was no outside persons present at the April council meeting.
6. **Committee Reports/Updates:**
 - A. **Budget Update:** The council was presented with a year-to-date report. Councilmember Kelsey Malcolm made a motion to accept the budget report and Councilmember William Malcolm seconded the motion. All were in favor and the budget report was approved.
 - B. **GDOT Application & Signage update:** Our application has been accepted and Mayor Randy Garrett will meet with Gary Potter and discuss placement of signage on Hwy. 83 and Hwy. 186.
 - C. **GIRMA (insurance) policy:** The policy has been received and the payment of \$3500.00 has been mailed.
 - D. **SPLOST funds and City projects update:** The cost of the sidewalk project on Pleasant Valley Road is \$184,000.00 and at present we have \$105,459.96 in our Special Purpose account, therefore the Council will need to revise the plan.
7. **Unfinished business:** There was no unfinished business to discuss.
8. **New Business:** Crissy Robinson has been appointed to fulfill the vacant seat on Planning and Zoning currently occupied by Mayor Randy Garrett.
9. **Council Discussion Items:**
 - A. **City Hall Rental:** Even with having no rentals the first quarter of 2021 we are doing well with recouping, as we have already had 4 rentals and several other upcoming dates scheduled.
 - B. **Community Event:** The council decided not to have a Poppy Festival at this time but instead to have a welcome back to normal event. We have not set a definite date, but

early June was discussed. Councilmember Kelsey Malcolm will be checking about a band and Councilmember Keith Prather is looking into food options.

- C. **Flood Hazard Map:** There are no physical copies of the proposed flood map, but there are digital copies that can be accessed on Facebook. Good Hope did have 3 houses move out of the flood plain.
 - D. **America Rescue Act:** There are federal dollars available, the city can receive up to three fourths of our 2020 operational budget of \$36,000.00 which would be \$27,000.00.
10. **Adjourn:** Councilmember Keith Prather made a motion to adjourn the meeting, Councilmember Kelsey Malcolm seconded, all approved and the meeting was adjourned.
