Good Hope City Council Minutes June 7, 2021

1. **Call to order:** Mayor Randy Garrett called the meeting to order at 6:30 pm followed by the invocation. Councilman William Malcolm led the pledge.
2. **Roll Call:** Performed by City Clerk Missy Daigle, Council Members Keith Prather, William Malcolm, Kelsey Malcolm, and David Mullis were in attendance.
3. **Approval of agenda:** Mayor Randy Garrett called for an amendment to the agenda, 8B/9E change of date for July meeting. A motion was made by Councilmember William Malcolm to amend the agenda and Councilmember David Mullis seconded the motion.
4. **Approval of previous meeting's minutes:** Councilmember Keith Prather made a motion to accept May Council minutes. Councilmember Kelsey Malcom seconded, all approved, motion passed and minutes were recorded.
5. **Public Forum:** There was no outside persons present at the June council meeting.
6. **Committee Reports/Updates:**
 - A. **Budget Update:** The council was presented with a year-to-date report. Councilmember William Malcolm made a motion to accept the budget report and Councilmember David Mullis seconded the motion. All were in favor and the budget report was approved.
 - B. **Signage update:** Mayor Randy Garrett met with Gary Potter and the new signage that was agreed upon by the Council and will be placed on Hwy. 83 and Hwy. 186.
 - C. **SPLOST funds and City projects update:** At this time the Council decided to use funds to take care of the drainage issues on Pleasant Valley Rd., to update the Pavilion, to purchase public trash cans for the park and Pavilion area. It was also discussed to possibly partner with Road Development with the sidewalk project when they widen Pleasant Valley Rd.
7. **Unfinished business:**
 - A. **Community Event:** A date was set for our community event, Friday July 23, 2021 from 6:30-9:00 pm. Kelsey Malcolm will be the point of contact.
8. **New Business:**

9. **Council Discussion Items:**
 - A. **City Hall Rental:** Rentals are picking up and we are on track to exceed our budgeted amount.

 - C. **Committee taskings:** Comprehensive planning will begin in July with Walton County, county cities, and the NEGRC. Walton Co. LDO amendments need to be reviewed to see if we need our LDO amended.
 - D. **America Rescue Act:** As an entity we now have a Dunn & Bradstreet rating and have turned in the appropriate forms for the American Rescue Act, we are now waiting for approval to receive \$27,000.00. Mayor Randy Garrett also applied for the infrastructure funds that are available for shovel ready jobs.
 - E. **Other:** The Council decided that our regular July meeting will be held on July 12, 2021 at 6:30 pm due to the July 4th holiday.
