Good Hope City Council Minutes November 14, 2022

1. **Call to order:** Mayor Randy Garrett called the meeting to order at 6:30 pm and led the invocation, Councilmember Keith Prather led the pledge.
2. **Roll Call:** Performed by City Clerk Missy Daigle, Council Members Kelsey Malcom, William Malcom, Keith Prather, and John Robison Jr. were in attendance, Councilmember David Mullis was absent.
3. **Approval of agenda:** There were no amendments to be added, Councilmember Keith Prather made a motion to accept the agenda and Councilmember William Malcom seconded and the agenda was approved.
4. **Approval of previous meeting's minutes:** Councilmember William Malcom made a motion to accept October Council minutes and Councilmember John Robison seconded, all approved, motion passed and minutes were recorded.
5. **Public Forum:** Tonya Wallace was present to discuss the upcoming Santa Workshop.
6. **Committee Reports/Updates:**
 - A. **Budget Update:** The council was presented with a year-to-date report. Councilmember Keith Prather made a motion to accept the budget report and Councilmember William Malcom seconded the motion. All were in favor and the budget report was approved.
 - B. **City Hall rentals:** Councilmember Keith Prather is reaching out to Bruce Peters as discussed in our October meeting, to clean out the septic tank due to the number of rentals that we have been having, also, the county will be contacted to get a sign made for the number of occupants in the building.
 - C. **Agreed Upon Procedures (2021):** During the Council meeting the clerk reached out again to Mr. McNair since there had not been an update, he stated the information for the agreed upon procedures had been reviewed and that he would be submitting it to state by weeks end.
7. **Unfinished business:** There was no unfinished business.
8. **New Business:**
 - A. **Reading and vote by council of the Flood Damage Prevention text amendment (2) to the Land Development Ordinance:** Mayor Garrett read through the articles of the Ordinance with the date changed from October 3, 2022 to February 4, 1985, this was the third reading. After the reading the mayor called for a motion to approve the new ordinance, "2022-03", Councilmember Keith Prather made a motion to approve the new ordinance as amended and Councilmember John Robison seconded the motion and the motion past 100%.
 - B. **Tree Council Request/Arbor Day:** To keep our Tree City Status we will need to have an event by April 22, 2023, Jason Laughinghouse was supposed to be present to discuss, due to his absence this will be discussed at a later date.
 - C. **Rescheduling of December Council meeting:** Due to the runoff election our December meeting will be on December 12, 2022, Councilmember Keith Prather made a motion to change the date to the twelfth and Councilmember Kelsey Malcom seconded the motion and the motion passed 100%
9. **Council Discussion Items for the good of the order:**
 - A. **Santa Workshop:** Councilmember Kelsey Malcom asked Tonya Wallace to discuss the upcoming event, the Santa Workshop. She let the council know that there would be cocoa, hotdogs, roasting marshmallows, cookie decorating, a hay ride, pictures with Santa, and the lighting of the tree. She also stated that there is room for volunteers.
