Good Hope City Council Minutes April 3, 2023

1. **Call to order:** Mayor Randy Garrett called the meeting to order at 6:31 pm, gave the invocation and led the pledge.
2. **Roll Call:** Performed by Rachel in the absence of City Clerk Missy Daigle, Councilmembers William Malcom, John Robison, Jr., David Mullis, and Keith Prather were in attendance, Councilmember Kelsey Malcom was absent.
3. **Approval of agenda:** There were no amendments to be added, Councilmember Keith Prather made a motion to accept the agenda and Councilmember John Robison, Jr. seconded and all approved.
4. **Approval of previous meeting's minutes:** Councilmember Keith Prather made a motion to accept March Council minutes and Councilmember William Malcom seconded, all approved, motion passed and minutes were recorded.
5. **Public Forum:** No one present for a forum.
6. **Committee Reports/Updates:**
 - A. **Budget Update:** The council was presented with a year-to-date report. Councilmember William Malcom made a motion to accept the budget report and Councilmember John Robison, Jr. seconded the motion. All were in favor and the budget report was approved.
 - B. **City Hall rentals:** We are presently \$425.00 above the \$2000.00 that was budgeted for income with rentals. As discussed at last months council meeting the cost of cameras is being looked into.
 - C. **Agreed Upon Procedures (2022):** The Clerk mailed the flash drive with the city's information to the new CPA, Samuel Latimer, he has received it and will begin working on our AUP.
7. **Unfinished business:**
 - A. **Arbor Day Event:** The Arbor Day event will be rolled into the Poppy Festival for one event that will be taken care of by "Good Hope Together".
 - B. **Poppy Festival:** The Poppy Festival is on the calendar for May 20, 2023, the Moina Michael project will be inside City Hall, while the vendors will be set up outside. Donations are coming in and "Good Hope Together" is working hard to have a successful event.
8. **New Business:**
 - A. **GMA City of Ethics Resolution:** After Mayor Garrett read the resolution Councilmember Keith Prather made a motion to adopt the resolution, Councilmember William Malcom seconded the motion and the motion passed 100%. The resolution will be renewed every 4 years.
 - B. **Joint City/County paving project:** There was Council discussion about the paving of Jacks Creek Road, John Alman from the county, felt it was a priority. Councilmember Keith Prather made a motion for the City to purchase the asphalt at \$93,610 and have the County spread it, Councilmember David Mullis seconded the motion and the motion passed 100%. This project will be paid for with SPLOST 4 funds.
9. **Council Discussion Items for the good of the order:** It was discussed to have the Pavilion and the brick façade pressure washed as well as the walk paths, it was agreed that the mayor would get a quote and schedule.
10. **Adjourn:** Councilmember William Malcom made a motion to adjourn the meeting, Councilmember John Robison, Jr. seconded, all approved and the meeting was adjourned at 7:12 pm.
